ORDER

As per the Government Order read as 1st paper above , Government have accorded Administrative sanction for entrusting the construction work of proposed building for SASA with BSNL(Civil) in a phased manner. As per the minutes of the meeting read above , the decision was taken to shift the office of SASA which is now functioning in a rented building at Kattakkada to the first floor of the GIFT old building at Kaimanam,where PPRI is accommodated subject to the outcome of the case before the Hon'ble court .

As per the letter read above, the Director(SASA) has informed that BSNL was entrusted with the construction of work of SASA in the one acre of land made available to Government at free of cost by Vigyan College of Applied Science Kattakodu,Poovachal ,Kattakkada. Sri. K.L Pradeep,Secretary,K.S Nair Foundation has registered this land at free of cost in the name of the Hon.Governor as per deed No.2190/2015 dated 28/12/2015.One of the conditions of the deed is that the land can only be used for the SASA and its allied institutions and cannot be used for other institutions and if the functioning of the institution after constructing the building is not started within a period of two years of the deed ,the land has to be automatically go back to the donor.The office of SASA has been working in a rented building at Kattakada @Rs.42,987/- per month. But the rent agreement has not been registered till date.

Having examined the matter in detail, Government are pleased to accord Administrative sanction for the following

1. To temporarily shift the office of the SASA from the rented building at Kattakkada to the first floor of the GIFT old office at Kaimanam, where PPRI is accommodated subject to the outcome of the case before the Hon'ble court and renovate the office on shifting.
2. The funds allotted by GOI will be used for the construction of new building of SASA at one acre Govt land available at Kaimanam and BSNL will be entrusted to prepare the plan, estimate and execution of work.
3. The land made available at Kattakkada for the construction of SASA by Sri. K.L. Pradeep, Secretary, K.S Nair Foundation shall be given back to him.
